We appreciate your visit to our trade show and would like to inform you about how we handle your personal data. The security of your data is important to us, and we strictly adhere to data protection laws, especially the provisions of the General Data Protection Regulation (GDPR).

#### 1. Responsible Party

#### 2. Data Collection

We only collect and process personal data that we receive from you in the course of a business contact or that you have provided to us, for example, through inquiries, deliveries, services, or other business contacts, and we capture this information in our "Visit Report" app.

- Name, first name of the contact person
- Company name
- Company address
- Business phone number
- Business email address
- Possibly, position in the company



#### 3. Purpose of Data Processing

We collect and process data for the purpose of potential business initiation, contract fulfillment, and support of business development.

The contact information you provide to us is collected to send you information about our company, as well as offers, orders, and samples of our products that may be of interest to you.

Additionally, the data is used to create a customized trade show report that provides an overview of the event for both you and us.

### 4. Legal Basis

Legal basis for the processing of personal data:

- For the transmission of information about the company and products, Art. 6 (1) a GDPR
- For the execution of deliveries and services, Art. 6 (1) b GDPR
- For suppliers, prospects, and other service providers in the context of business initiation, Art. 6 (1) f
  GDPR

### 5. Data Recipients

Your data is only used internally within the SpanSet Group for the purposes mentioned above and is not disclosed to third parties.

#### 6. Storage time

Data from orders and the provision of services is stored in accordance with the legally prescribed retention periods under §§ 146 of the German Fiscal Code (AO) and § 257 of the German Commercial Code (HGB) and deleted after the expiration of the retention obligations.

Personal data of other business contacts are stored as long as the respective person is of business relevance to us.

This is internally reviewed every 12 months. Subsequently, data is archived if necessary to fulfill a legal retention obligation.



## 7. Rights of Data Subjects

You have the following rights:

- Right to information (Art. 15 GDPR)
- Right to rectification of incorrect data (Art. 16 GDPR)
- Right to erasure or the right to be forgotten (Art. 17 GDPR)
- Right to restriction of processing of personal data (Art. 18 GDPR)
- Right to data portability (Art. 20 GDPR).

You can object to the processing of your personal data for advertising purposes at any time without providing reasons.

In addition, you also have a general right to object (cf. Art. 21 (1) GDPR). In this case, the objection against data processing must be justified. If data processing is based on consent, this consent can be revoked at any time with future effect.

You also have the right to lodge a complaint with a supervisory authority regarding the data processing carried out by us.
